## DELAWARE PREVAILING WAGE INFORMATION

Fringe benefits may be considered in determining whether an employer has met his/her prevailing wage obligations. However, any contributions made by employees must be voluntary. The only fringe benefits which the Delaware Department of Labor will recognize are the following:

- » Health Insurance
- » Life Insurance
- » Disability Insurance
- » Retirement Benefits
- » Vacation Pay
- » Holiday Pay
- » Sick Leave Pay
- » Bereavement Leave
- » Education Benefits related to apprenticeship and training programs
- » Supplemental Unemployment Benefit

List only those fringe benefits:

For which the employer has paid; and which have been used to offset the full prevailing wage rate.

(See Delaware Prevailing Wage Regulations for explanation of how hourly value of benefits is to be computed.)

To calculate the cost per hour divide 2,000 hours into the total employer benefit cost per year for each employee

That any apprentices employed in the above period are duly registered in a bona fide apprenticeship program registered with a state apprenticeship agency recognized by the Bureau of Apprenticeship and Training, United States Department of Labor, and that the worksite ratio of apprentices to mechanics does not exceed the ratio permitted by the prevailing wage regulations of the State of Delaware.
